### OFFICIAL PROMOTION RULES

#### 1. Eligibility

*Stay Connected (the Promotion)* is open to new and existing members of Red River Employees Federal Credit Union who are at least eighteen (18) years old at the time of entry. Current members must be in good standing. New members are eligible to participate on the date the membership and account become active. Employees, Directors, and Officers of Red River Employees Federal Credit Union are not eligible. Non-members and owners/signers of a Representative Payee Account, Trust Account, Estate Account, Sole Proprietorship Account, or Business/Organization Account are not eligible.

#### 2. Sponsor

The Promotion is sponsored by Red River Employees Federal Credit Union, located at 2700 A University Avenue, Texarkana, Texas, 75503.

#### 3. Agreement to Official Rules

Participation in the Promotion constitutes entrant's full and unconditional agreement to and acceptance of these Official Promotion Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with the Official Rules and fulfilling all other requirements set forth herein.

#### 4. Promotion Period

The Promotion begins on March 11, 2019, and ends April 19, 2019, at 5:00 pm CST (the "Promotion Period"). Entries submitted before or after the Promotion Period will be disqualified.

#### 5. How to Enter

Limit one (1) entry per member. Multiple updates to member contact information can be submitted to ensure accuracy, but only the first qualifying entry will be entered in drawing. Entrant must verify or update Member Contact Information, which includes mailing address, phone numbers (Home, Mobile, and/or Business), email address (if existent), using the following Red River Employees Federal Credit Union approved methods:

**In person**—With Red River Employees Federal Credit Union employee assistance, entrant will present valid ID to verify Member Contact Information in person. Employee will guide member through quick process. Entrant may request a blank form to be completed and returned at a later date.

**By Mail**— Member may request a Change of Address Form by phone, in person, or retrieve a copy form [www.rrfcu.com](http://www.rrfcu.com), to complete and return form by mail or in person. Facsimiles (fax copies) will not be accepted. Eligible entries must be received on or before April 19, 2019.

**With Online Banking**—Member may log on to Online Banking and select Change Address under the Your Homebanking tab. Member will make appropriate updates and enter current password before selecting "Update Member Info."

If no change is required, Member must follow **In Person** or **By Mail** options above.

**6. Prize Drawing – One Weekly Winner each week for 6-Week Promotion**

Winners will be selected in a random drawing from all eligible Change of Address completed and properly submitted in person or by form (See form for required information). All eligible submissions will be kept in the prize drawing pool until drawn as a winner or the end of the Promotion, whichever comes first.

**7. Winner Notification**

Weekly winners will be notified by Friday of the week following each weekly drawing. If Sponsor is unable to notify the winner due to incorrect or outdated information on file, winner will forfeit winnings. Upon notification and verification of identity, the winner may be asked to come to a specific Red River Employees Federal Credit Union office for a brief presentation ceremony or photo opportunity. Winner hereby irrevocably consents to and authorizes Sponsor and its agents or anyone else authorized by Sponsor, to use and reproduce any and all photographs or other types of images, voice recordings and/or video or writings that Sponsor takes or records related to the Promotion. Images, recordings, videos or writings, with or without winners name, may be used for any purpose, whatsoever, including but not limited to, purpose of publicity, advertising, banners, illustration, posters, publications, writings and web content, in connection with Sponsor in print or electronically. Entrant understands and agrees that these materials will become the property of Sponsor and will not be returned. Additionally, winner waives any right to royalties or other compensation arising or related to the use of the photographs, writings, etc.

**8. Prizes**

There will be one winner each week for six weeks of a cash deposit to the winners' membership account in the amount of \$100.00. All federal and state taxes on prizes are the sole responsibility of the winner. If applicable, the winner will be issued a 1099 tax form for the actual amount of the prize. Winner may refuse cash amount at any time, for any reason.

**9. General Conditions**

In the event that the operation, security, or administration of the Promotion is impaired in any way for any reason, including, but not limited to fraud, malicious code, unauthorized human intervention or other technical problem, or in the event the Promotion is unable to run as planned for any other reason, as determined by Sponsor in its sole discretion, the Sponsor may either (a) suspend the Promotion to address the impairment and then resume the Promotion in a manner that best conforms to the spirit of these Official Rules or (b) terminate the Promotion. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to damage the website or undermine the legitimate operation of the Promotion may be in violation of criminal or civil law, and, should such an attempt be made the Sponsor reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision or any other provision.

**10. Release and Limitation of Liability**

By participating in the Promotion, entrants agree to release and hold harmless the Sponsor, and each of their Officers, Directors, employees, representatives, and agents (the Released Parties) from and against any claim or cause of action arising out of participation in the Promotion or receipt or use of the prize (including any travel or activity related thereto), including, but not limited to: (a) any technical errors associated with the Promotion, including lost, interrupted or unavailable Internet Service Provider (ISP), network, server, or other connections, availability or accessibility or miscommunications or failed computer transmission or computer hardware or software malfunctions, failures or difficulties; (b) unauthorized human intervention in the Promotion; (c) mechanical, network, electronic, computer, human, printing or typographical errors; (d) any other errors or problems in the administration of the Promotion, the announcement of the winner, or the cancellation or postponement of the events; or (f) injury, death, losses or damages of any kind, to persons or property which may be caused, directly or indirectly, in whole or in part, from entrants participation in the Promotion or acceptance, receipt or misuse of the prize (including any travel or activity related thereto). Entrant further agrees that in any cause of action, the Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Promotion. Entrant waives the right to claim any damages whatsoever, including, but not limited to, punitive consequential, direct, or indirect damages.

**11. Disputes**

Except where prohibited, each entrant agrees that any and all disputes, claims and causes of action arising out of, or connected with, the Promotion or any prize awarded shall be resolved individually and in the sole judgment of Sponsor, without resort to any form of class actions. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, entrants' rights and obligations, or the rights and obligation of the Sponsor in connection with the Promotion, shall be governed by, and construed in accordance with, the laws of the state of Texas.
